



**Illustrative With Profits MVR and Final Bonus Rates, SMI June 2013  
(Effective Tuesday 4<sup>th</sup> June 2013)**

It should be noted that these illustrative MVR (indicated by –) and Final Bonus (indicated by +) rates and any policy value quotations based upon them are in no way guaranteed and are subject to fluctuation in either direction at any time without prior warning, dependent upon a number of factors, notably stock market conditions and the volumes and amounts of any actual surrenders received or expected.

In particular, in the event of an actual surrender request being received for a large case, the level of MVR or Final Bonus will be reviewed on an individual basis, to ensure the value fairly reflects the investment returns earned on the fund during the period of investment, and the resultant MVR or Final Bonus may not be as in the Illustrative Table below.

The rates vary according to the month in which the policy was taken out (or invested into the With Profit Fund), the currency of the with profit sub-fund invested in, and whether the policy is invested in the 'SMA OLAB' Fund (where the unit liability is reassured into Scottish Mutual Assurance) or the 'Dublin' Fund, where the liability is retained in Scottish Mutual International.

The policy documentation will indicate which fund is applicable.
